- Understanding and intentionally safeguarding the person’s vulnerabilities
- Family governed models
- Imagining better
- Understanding the person and their unique needs
- Identification of strengths and capabilities
- Sustaining success in valued roles
- Effectively and repeatedly problem solving any challenges that may arise

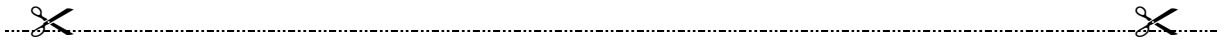
