Much of CRU's work is self-financed through fees. CRU was founded in 1988.

- Drawing attention to, and providing information relevant to key challenges in the disability field.

- ◆ Inspire and encourage individuals and organisations to pursue better lives for people with disabilities.

- ◆ Educational events throughout Queensland
- ◆ Leadership Development Programs and Strategies
- ◆ Service & Organisational Development work (including advice, planning, evaluation and training)
- ◆ Service Reform Consultancy
- ◆ Project Work in areas of key importance
